Gift baskets, cameras, crystal, books, subscriptions, games, sports equipment, luggage, rental cars.

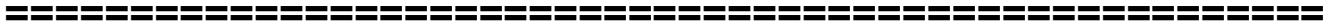
Whether you're an attraction, destination, airline, hotel, car rental, park, restaurant, museum, retail store, river outfitter, etc., ***we need your donation.***

- ✓ Items must have a minimum retail value of \$100.
- ✓ All components of packages must be good through at least August 1, 2020 with all details, dates, special events and information necessary to redeem the package clearly stated on the certificate or company letterhead.
- ✓ All packages must clearly state travel dates, special events or seasonal restrictions.
- ✓ If multiple entities contribute to a package, each component should have a minimum retail value of \$100 to be recognized individually in the auction catalog.

- ✓ All items must meet minimum retail value requirements.
- ✓ AzLTA & GCOT reserve the right to return any donations deemed inappropriate or not meeting specified requirements.
  - ✓ AzLTA & GCOT recommends that all items and certificates be shipped via parcel or carrier service, using adequate packing materials to ensure that the item(s) arrive intact, especially for fragile items. GCOT cannot be held responsible for items that arrive in imperfect condition.
- ✓ All components of travel packages must be good through at least August 1, 2020, unless stated otherwise.
  - ✓ All certificates and/or cover letters must clearly state all components of the package, product, or service donated, and outline specific redemption procedures.
